During his diploma thesis at the chair of Prof. Hänsch at the Ludwig-Maximilians-Universität Munich, he became enthusiastic about laser physics. Thus he joined TOPTICA Photonics, which was founded as a startup company at that time. In the following years he worked in research and development of semiconductor lasers and ultrafast fiber lasers, where many products of TOPTICA Photonics AG originated. Subsequently, he headed the R&D department of TOPTICA in the field of fiber lasers and frequency comb technology. As a co-founder of TOPTICA Projects GmbH, he has overseen the company's R&D since its spin-off in October 2016.
